1. The price of material set forth herein shall include the cost of delivery FOB destination 1936 W. 18th Street, Port Angeles, Washington 98363. The District will provide unloading equipment; therefore, arrival date shall be specified two (2) days prior to arrival. Provision shall be made for carrier to deliver on a weekday(s) between Monday and Friday and between 8 a.m. and 4 p.m. The District reserves the right to deduct the following amounts from the bid price after the quoted delivery date: first thirty (30) days after required delivery date, \$100 each calendar day; each succeeding calendar date thereafter, \$200 per calendar day.
